Snowy Owl Culling at Port Authority Airports

Devin is an avid birder who spends much of his free-time in the woods and on the beaches of New England. After learning of the culling of Snowy Owls at Port Authority airports in New York and New Jersey, he began a grass-roots campaign in an effort to educate the Port Authority on the non-lethal methods being employed by Logan Airport and Mass Audubon. Inspired by The Snowy Owl Project's efforts, he created a "Change.org" petition and spread the word via social media. The petition quickly gained the attention of national and international news agencies and received nearly 12,000 signatures in four days. The Port Authority quickly changed their strategy after the groundswell of support for non-lethal methods; an extremely rewarding experience and satisfying result.
